

HOW WILL THE ELECTION AFFECT YOU?



WASTEWATER ANNEXATION ELECTION

Eligible voters are being asked to vote on a two-part proposal:

Part One: Annexation

Annexation would:

- Combine current City of McCall sewer customers with PLRWSD customers.
- Give one entity, PLRWSD, ownership and operational control over wastewater collection, treatment, and disposal for the McCall area.

Part Two: \$22.07 Million Bond

The total bond would fund:

- Necessary upgrades to the reuse water disposal system to implement the new Reuse Permit from Idaho Department of Environmental Quality - \$11.7 million.
- Improvements to the wastewater treatment plant - \$3.3 million.
- Acquisition of the system assets and the retirement of existing debts - \$7.07 million.

VOTER CHECKLIST

- ❑ **Determine if you are eligible to vote and what you will be voting on.**
 - » Visit the website www.MccallAreaWastewater.com.
 - Complete the two-step Elector Decision Tree process or use the interactive mapping app.
- ❑ **Register to vote.**
 - » Register to vote by mail, or in person in the county in which you reside by April 21st, or at the election site, McCall Donnelly High School, on May 16th.
- ❑ **Request an absentee/vote-by-mail ballot.**
 - » Any registered voter may apply for an absentee ballot by completing a Request for Absentee Ballot Form. Select one of the following options to get the form:
 - Online: Visit www.McCallAreaWastewater.com to download and complete the form or email elections@co.valley.id.us to request a copy.
 - In person: Visit McCall City Hall or the PLRWSD Office to complete a form and have the ballot mailed to you.
 - By mail: Submit a request to Valley County Elections, PO Box 1350, Cascade, ID 83611.
 - By phone: Call the Elections Department at 208-382-7100, and we will mail you the form.
- ❑ **Vote in person.**
 - » Vote in person before election day, April 14th through May 12th.
 - Visit the Valley County Clerk's Office at 219 N Main Street, Cascade, ID.
 - » Vote on May 16th at McCall Donnelly High School.
 - Call the Elections Office at 208-382-7100 or PLRWSD at 208-634-4111 with questions.
